January 17, 2013

A meeting of the City of Bondurant Parks and Recreation Board was held in the Community Room at the Bondurant City Center on January 17, 2013, at 6:30 p.m.

Notice of the meeting was posted at the Bondurant City Center, Casey's General Stores, Legacy Bank and the Bondurant Post Office on January 11, 2013. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Recreation Coordinator Hagan called the meeting to order at 6:30 p.m. No action was taken due to lack of a quorum.

Board Chair Cook updated Board Member E. Johnson on the Parks Master Plan interviews for engineers that took place on January 16, 2013.

Regional Trailhead Update- Board Chair Cook went over dates of concrete pouring and wood delivery.

Board Member E. Johnson discussed the BSC 2012-2013 report. He explained that every year is growth and last year there were enough kids to have their own teams (enough girls for girls teams and enough boys for only boys teams). BSC is looking for more land to build a full-size field and is inquiring about sharing space with the school by the football field. Board Chair Cook asked about growth and the numbers and would like to know if the board has their eye on particular land. Also would like to know if Thad went to Council for approval.

Recreational Coordinator Hagan met with the high school and middle school principals regarding what programs could be held on Mondays. The principals suggested programs for

student athletes from the time school ends to the time their practices would start. High school students need 50 hours of community service so it is suggested it could be a combination of helping out all students.

2012/2013 Recreation Programming: (As discussed by all Board Members present)

Cribbage Tournament- Is January 27, 2013. A board member needs to be here at 1:00 p.m. There are 12 people signed up so far.

Babysitting class- Recreational Coordinator is working with Board Member Bruce on collecting information from different companies regarding educational handouts, dolls, and first aid, CPR. Class would be held at the City Center for girls 10-12 years old. \$25.00 admission and they need to bring their own lunch. Recreational Coordinator will be inquiring with Polk County to educate about different emergency information and with Joyce Higgins for first aid and CPR.

Dodgeball- February 9, 2013 1-4 p.m. is for adults 18 & older. February 16, 2013 from 8-12 p.m. is for youth 7-12 and youth 13-17 will play from 1-4 p.m. at the middle school. No one is signed up yet.

The Luck of Bondu Photo Scavenger Hunt- Recreational Coordinator Hagan is setting up a St. Patrick's Day themed event for March 8, 2013. She is getting Founder's to donate items for the winner's since the participants will be ending at Founder's Irish Pub. Board Chair Cook asked if they get extra points for finishing early. Board Member E. Johnson wanted to know if the items on the list were easy enough for all to find.

- Presenting Council with a 5 minute update on goals for year at the January 21 Council meeting.

The following items were discussed as part of the Recreation Coordinator's comments:

- Summerfest June 26 & 27, thinking about a bingo tent and 3 on 3 basketball at City park.

The following items were discussed as part of the Board Member's comments:

- Board Member E. Johnson asked if we should hire someone for bingo.
