A special meeting of the City of Bondurant Parks and Recreation Board was held in the Community Room at the Bondurant City Center on April 9, 2013, at 6:30 p.m.

Notice of the meeting was posted at the Bondurant City Center, Casey's General Stores, Legacy Bank and the Bondurant Post Office on April 8, 2013. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Jeff Cook called the Board meeting to order at 6:30 p.m. Don Marner went over a brief overview of the project schedule, park design updates, cost options and trail routing. Budgetary Opinion for Eagle Park, Lake Petocka, BRSC, City Park and Gateway Park was discussed. City Administrator Arentsen added the location for a concrete slew to the layout for Eagle Park.

Lake Petocka- Board Chair Cook asked about the pricing for a gravel parking lot and also about the fence on the northeast side of Lake Petocka. Don will be looking into a price for gravel compared to PCC. City Administrator Arentsen suggested a small parking lot off the trail by Petocka South Shelter. Administrative Assistant Richardson-Kugler mentioned moving the volleyball court to where the garden is now to make room for parking.

Gateway Park- Don did not add the price for flag poles, flag poles could get expensive and there are many varieties. City Administrator Arentsen likes Don's layout for using both sides of Grant St S.

Wolf Creek- Board Chair Cook questioned the cost of 6' compared to 8' or 10' trail around Wolf Creek and inquired about the circulation to others. This trail could possible connect to Mud creek.
